Salt Lake County Now Offers a Local Preference for Solicitations over \$5,000 – As of May 15, 2008, Salt Lake County implemented an Ordinance change which allows local vendors to apply for a preference. The guidelines are as follows:

A local preference may apply to a vendor who submits the lowest, responsive price for goods and/or services. Other factors to be considered for a preference are: (1) offeror must agree to provide a complete and signed Local Certification Form (which includes a street address within the County that is not a post office box), (2) a copy of a current business license issued by the County (or any other city within the boundary of the County) which is valid for a minimum of six (6) months prior to the publication of the solicitation, and (3) proof of registration with the Utah Department of Commerce.

Offers must still be competitive; for the preference to apply, pricing must be within 4% of the lowest price offered which does not claim a preference.
